Civic Dinner update

Public Rights of Way BW251



Public Right of Way 251 within Kirton-in-Lindsey is located along Cleatham Road between the railway bridge and the garden centre. The right of way is along the edge of the drive to West View House and ceases at the railway embankment, previously servicing access to the railway platform long removed. The right of way is designated a bridleway but for some time has had a stile as the access point and so has prevent horses and cyclists using it.

The Town Council has recommended that North Lincolnshire Council to give consideration to whether the equestrian rights to BW251 could be stopped up (which would extinguish the right of way for cyclists too).

NLC will therefore carry out an informal consultation with parties they should statutorily need to serve notice on to establish whether removal of equestrian and cyclists rights to use this public right of way is expedient on the grounds that the equestrian rights are no longer needed by the public, this being the necessary legal test if ultimately we choose to proceed.

Community Speedwatch

Following many complaints from residents in regards to speeding through the town, the Town Council has approached Community Speedwatch to help tackle the continuing issue.

Community Speedwatch is a national initiative where active members of local communities supported by Humberside Police monitor speeds of vehicles using speed detection devices.

Vehicles exceeding the speed limit are referred to the Police with the aim of educating drivers to reduce their speeds. In cases where education is blatantly ignored and evidence of repeat or excessive offences is collated (even across county borders), enforcement and prosecution follow.

To operate the scheme a small number of volunteers who are prepared to commit 1-2 hrs a month are required. You will then work in teams of three and full training will be provided together with support from Humberside Police.

Grove Street Cemetery



Kirton-in-Lindsey Town Council offices have unfortunately received a number of complaints from residents and visitors in relation to our cemetery over the past few months. These complaints are primarily that Cemetery Regulation are not being adhered to in relation to what floral, planting and ornamental tributes are permitted within these regulations.

The Town Council is mindful that this can be a difficult issue to raise with cemetery users and grave owners, but are equally mindful that it is Councils responsibility to ensure Regulations are adhered to.

We plan to initiate a phased approach to returning the cemetery to the prescribed standard, but wish to ensure all families /residents and grave owners have the opportunity to review the Regulations in relation to their plots, allowing time for individuals to make required adjustments where necessary.

We fully realise this to be a sensitive subject, and have no wish to create any distress to our cemetery users. We do though hope to be able to conduct this review with minimum distress. The Cemetery regulations are posted on its noticeboard, in addition we are happy to provide copies and clarification where required.
