Dog fouling – Tackling the problem as a community

Cllr Fox recently launched this initiative around tackling dog fouling together as a community, so please get involved if you can.

Dear Residents

It's a common problem for most Towns and Villages and one which gets many people hot under the collar.....the scourge of dog owners who don't clear up after their pets. No one wants to have to clean their shoes or pram wheels of this and as the dark nights are now upon us, spotting it before this happens is almost impossible.

So, what can be done to rid streets and parks of their mess and persuade all pet owners to act responsibly?

The Town Council is taking action:

- Planning a competition for the children of the Town to design a poster to be displayed around Kirton-In-Lindsey. It is hoped these posters will remind residents not to put the children's health at risk.
- Mapping where this is regularly happening. Are there particular streets which are worse than others? The North Lincolnshire Environment Protection Team will patrol areas if informed. To help with this, if you spot any dog mess, please report it to this email address:

Proposed new walking and cycling route for Kirton in Lindsey

Kirton in Lindsey Town Council are currently working with both North Lincolnshire Council and the Ministry of Defence with the aim to secure the Vincent Hall (old RAF gym) for use as a community sports facility for Kirton in Lindsey.

As part of this work, improved walking and cycling access to the building is under consideration. As part of a wider scheme of proposed new and improved walking and cycling routes across North Lincolnshire, your views are sought on the proposal for a new route within Kirton in Lindsey.

Street sports

You may be aware that StreetSports was withdrawn from Kirton in Lindsey last October. The Town Council is keen to bring some sporting activities along the lines of StreetSports back and needs to know if this would be supported or not. It would be planned in a similar way to StreetSports and take place in the early evening one night a week, most likely on the Green.



There may be a small charge per child for accessing the activities and securing the qualified coach to lead the sessions.

To provide evidence and make this happen, we need you to let the Town Council know your answers to these questions:

- Do you think an informal weekly sport/physical activity session is needed for young people in Kirton in Lindsey?
- Why do you think this is needed?
- If Kirton in Lindsey Town Council provided a weekly outdoor multi-sport session for 8 to 18-year olds for a small charge do you think your child would attend?
- Would you like to volunteer and assist a coach in providing the activities to help future proof the provision?
