### July 2021 Newsletter

*A brief update on activities and news from Kirton in Lindsey Town Council.*

#### **Grove Street Cemetery update**

Kirton in Lindsey Town Council, as the Burial Authority, has a duty under Health and Safety legislation to control the dangers that exist in the cemetery. This includes work to actively remove hazards posed by unstable memorials.

It is Kirton in Lindsey Town Council's intention to follow the latest guidance from the Institute of Cemetery and Crematorium Management (ICCM) and the Ministry of Justice on memorial safety and to take appropriate action to any memorial deemed unsafe within the cemetery.

All memorials should be inspected on a minimum 5 yearly cycle. The inspection will be fully documented, identifying all dangerous or unstable memorials.

Following the inspection, those memorials requiring action are marked for the owner's attention. It is the owner's responsibility to undertake any works required. This could include contacting memorial masons for advice and guidance. The Council should be informed of any works taking place in the cemetery prior to them starting, and confirmation should be provided when works are completed. This enables the Council to update all reporting to confirm the required works have been carried out and to ensure that any works do not cause disturbance to memorial services planned within the cemetery.

The owner of the memorial is responsible for maintaining the memorial in good condition and will be properly informed by their memorial mason of their and other party's responsibilities. Where owners cannot be traced the Town Council has to make a decision on how to deal with a memorial.

Notice will be given for any intended action to any memorial. If all attempts to contact the grave owner fail then the Town Council has the right to remove or take such steps as to make safe the hazard. This will also be the case for memorials where the grave owner or their heirs-at-law have been contactable but were either unwilling or unable to ensure a repair by a registered stone mason.

Kirton in Lindsey Town Council is conducting this survey in order to gain your views and opinions on aspects of the current facilities and events available within our town, in addition to proposed future amenities for our community.

The Town Council has a certain remit and is responsible for particular aspects of the town and community. An outline of the responsibilities of the Town Council – and what falls under the control of North Lincolnshire Council is displayed in the Town Council noticeboard, online and in the recent edition of Kirton First.

Existing facilities and events were created and are maintained using funding from a combination of the local element (Kirton in Lindsey) within your annual Council Tax and various grants that are available to Local Authorities. For large projects, in addition to any supporting Grant Funding and North Lincolnshire Council support, Town Councils can access Public Works Loans, which are available at very low interest rates and repaid over many years to ensure minimal impact on annual Council Tax payments.

We need YOUR opinion on what we have within our community, and what you would like to see in the future so we can plan accordingly. We will let you know what results and opinions the survey reveals, and what the subsequent plans for the town will be.

## **Dog fouling campaign continues**

Do you know about the free Pooper Snooper app which will allow you to easily flag up dog fouling incidents as and when you come across them, as well as register dog waste bins so that other dog walkers with the app can find their nearest bin.

The problem of dog waste on the pavements and open areas of Kirton in Lindsey is an ongoing concern, and Cllr Fox's work to promote responsibility and engage the North Lincolnshire Council (NLC) dog warden has helped with this a great deal. Kirton in Lindsey Town Council continue to engage with NLC on the locations of bins around the town to make sure they are in the right places, but this takes time.

The free Pooper Snooper app provides an easy way to develop evidence-based feedback about areas of particular concern. This will help us identify the troublesome areas and we can look at further methods of targeting those, with the help of enforcement officers.

The Town Clerk is currently registering all of the dog bins and litter bins (remember litter bins are dual use and you can use them for bagged dog waste too) in Kirton in Lindsey and it would be great if as many people as possible could take a look at the app and consider using it to register any uncollected dog waste spotted in the area.

The free app allows you to log: dog waste bins; dog fouling spotted; dog fouling cleaned up by you (not your own dog's). The information stays on the app for a few weeks to ensure the same poop isn't registered as more than one incident by different users.

Don't forget, if you are able and willing to identify irresponsible owners who aren't picking up after their dog you can report them to North Lincolnshire Council to issue a fine.

The free Pooper Snooper app can be downloaded from the Apple or Google stores.

Have a go and get logging!



Remember - by using the app to report dog fouling incidents, it creates a 'heat map' highlighting problem areas where new bins could be installed or enforcement officers could focus their time to help try to address this ongoing issue.

## Ongoing works....

Some residents will be aware of ongoing works around the town, and these include the installation of new lamp posts at Town Hall Passage, the start of works on the dropped kerbs programme, and the installation of the litter bin at the junction of South Cliff Road and the B1400. These are all developments from evidence presented to North Lincolnshire Council by Kirton in Lindsey Town Council. A review of litter bins and dog waste bins is ongoing by North Lincolnshire Council and evidence from feedback to the Town Council can help inform improvements on replacement or relocation of these if required following the completion of the review. North Lincolnshire Council are still planning to implement the trial one way system around the Market Place in the coming months. Feedback from the trial will provide evidence base for any permanent improvements to the traffic flow around the Market Place for all users including vehicles and pedestrians.
