



Minutes of the meeting of Kirton in Lindsey Town Council General Purpose Committee, held on Monday 14th October, 2019 at the Heritage Room, Town Hall, Kirton in Lindsey at 7.30pm.

MINUTES

- GP 1910/01 Apologies
Apologies for absence were received from Cllr Startin (other engagement).
- GP 1910/02 Declaration of Interests / Dispensations
a. No declarations of interest received.
b. A dispensation was granted to Cllr Pat Frankish to enable her to take part in discussions relating to In Bloom without having to declare a personal interest as a member of the In Bloom Group. This decision was made as without the dispensation the number of persons prohibited from participating in any particular business would be so great a proportion of the body transacting the business as to impede the transaction of the business. This dispensation shall expire on the date of Town Council elections in May, 2023.
- GP 1910/03 Minutes of the Previous Meeting
a. The Committee considered the Minutes of the GP Committee Meeting held on 9th September, 2019
RESOLUTION: That the Minutes be signed as a true and accurate record.
b. The Committee received an update from the Clerk regarding outstanding tasks and actions.
- GP 1910/04 Public Transport
The Committee considered issues regarding public transport and decided any actions required. Cllr Cooper noted concerns that timetables were no longer displayed at bus stops and instead a notice was displayed for users to text a number to find out when the next service was due at a cost of 25p per text.
RESOLUTION: That the Clerk queries this practice with NLC and requests timetables be reinstated at bus stops. **ACTION: Town Clerk**
The Clerk reported passenger figures were received from Hornsby's following the intervention of NLC. Figures May to September show that the bus service is getting used well by passengers from Kirton in Lindsey.
- GP 1910/05 Bio-diversity Policy
The Committee deferred discussion of the development of the policy to the next meeting of this committee. **ACTION: Town Clerk**
- GP 1910/06 Open Spaces
The Committee discussed forming a working group to develop a five year plan for maintenance and development of the play area on the Green.
RESOLUTION: That Cllr Cooper and Cllr Garritt meet with Cllr Kitchen during his next play area inspection to look at the current equipment together and identify next steps.
