**Minutes of the Kirton in Lindsey Town Council Meeting held on Wednesday 16<sup>th</sup> December 2015 at 7.00pm in the Town Hall, High Street, Kirton in Lindsey, DN21 4LZ**

- 15/16.162 To approve apologies for absence**  
Received from Cllr Thickett.

Cllr Layzell declared a DPI in item 177a - expenses payment.

  - The official launch date for the Call Connect Service had been arranged, Kirton in Lindsey would be receiving good coverage in several directions. The launch would be on the 15<sup>th</sup> February. Literature would be distributed to Parish Councils and magazines around a month in advance. It was hoped that the Klipper timetable could be arranged to fit in with the service.
  - An update was given on the application for the change of use of three of the hangars at the RAF Camp. Cllr Poole was concerned about the vehicle movements generated by this and had asked for clarification on expected tonnage of lorries coming in and out. The application had been withdrawn from the recent NLC Planning Committee meeting but would now be scheduled for next month, along with the application for the first hangar. Cllr Poole will inform the council what time the site meeting will be for the application. Three or four residents were looking to speak at the meeting in objection to the plans.
