#### Update from Kirton in Lindsey Town Council - COVID-19 Response



Kirton in Lindsey Town Council continues to put steps into place to support the community by all available means as the lockdown measures ease and facilities and services become available again.

- 1. The COVID-19 Community Response team, put into place on 17th March remains available for the community.
- 2. The play area on the re-opened on 4<sup>th</sup> July. You should read the guidance and information provided on the Town Council website prior to allowing children in your care to use the play equipment.
- 3. The cemetery at Grove Street remains open and accessible, as it has throughout.
- 4. The Town Council has begun to hold monthly virtual meetings in order to continue to progress matters for the community and update ongoing projects. The meetings are open to the public to join, just contact the Town Clerk for all the details you will need once the Agenda is published.
- 5. #### The Circus comes to The Green



Plans were made to bring James Richards Circus to the Green in May, along with other events including the NLC Foodfest and VE Day. These events could not go ahead at that time as originally planned. James Richards Circus has now ensured that they can hold the circus in a Covid-19 Secure environment. In order to do this they have put the following measures into place:

- Reduced capacity to 100 people per performance;
- Barriers to segregate seating to allow correct social distancing;
- Condensed performance to 1 hour with no interval;
- Working with the side walls lifted to allow extra ventilation;
- Spaced show times to allow a deep clean between audiences;
- Hand sanitizer points and signage;
- Card machines to accept contactless payments;
- Recording customer contact details for Track & Trace;
- Screen guards fitted to selling area;
- Refreshments sold in sealed packages.

## A Community Effort



Kirton in Lindsey Community come together to fight plans for development at Ings Road

Plans submitted by the Strategic Land Group for a development with a suggested layout of 79 new homes between Lane End and the public right of way to Scotton were refused by North Lincolnshire Council at their Planning Committee meeting held on Wednesday 26th September.

The plans had received over two hundred objections from residents and two detailed objections from Kirton in Lindsey Town Council due to factors including the proposed location and the implications on the open countryside, the access to amenities and the danger the increased volume of traffic would cause along this country lane.

The application was referred to the NLC Planning Committee due to the volume of public interest and objections and at the Town Council's request. At the meeting, residents Michael Orridge and David Garritt spoke to represent the views of the town and detailed the reasons for the objections, Ward Cllrs Neil Poole and Trevor Foster spoke against the proposals and local MP Holly Mumby-Croft also submitted a letter noting the objections received by residents.

The Committee did not agree with the Planning Officer's initial recommendations to approve the application and unanimously resolved to refuse it on grounds that the proposals were against planning policy.

Everyone who took an interest, commented and raised awareness to others about this planning application has played a part in the refusal of the application at this stage, and the collective efforts of the community should be recognised. This is an example of how a community coming together with a shared purpose can achieve a result, and everyone involved should be proud of the part they played at this stage of the process.

The Applicant could now appeal the decision (within 6 months), resubmit a revised application (within 12 months) or do nothing further.

## Wash your hands of coronavirus scams!

# Friends Against Scams aims to protect and prevent people from becoming victims of scams.

#### Be aware of people offering or selling:

- Virus testing kits these are only offered by NHS.
- Vaccines or miracle cures there is currently no vaccine or cure.
- Overpriced or fake goods to protect yourself from coronavirus such as anti-bacterial products.
- Shopping or medication collection services.
- Home cleaning services.

#### Protect yourself and others:

- Don't be rushed into making a decision. If it sounds too good to be true it probably is.
- Only purchase goods from legitimate retailers and take a moment to think before parting with money or personal information.
- Don't assume everyone is genuine. It's okay to reject, refuse or ignore any requests. Only criminals will try to rush or panic you.
- If someone claims to represent a charity, ask them for ID. Be suspicious of requests for money up front. If someone attempts to pressurise you into accepting a service they are unlikely to be genuine. Check with family and friends before accepting offers of help if you are unsure.

Be a good friend, help to protect your family, friends and neighbours from scams.

#### Path linking East Dale Drive to Station Road.



The Town Council has worked with Ongo (as owners of the land) to construct a footpath between East Dale Drive and Station Road Co-Op.

This work will create a safe route, particularly in wet winter weather, for the benefit of the community and is the preferred solution rather than closing the gap and removing the access route which also previously served the First and Last pub. Works are ongoing at this time and so please be aware that there is likely to be temporary restricted access while the path is constructed.
