A brief update on activities and news from Kirton in Lindsey Town Council.

Grove Street Cemetery update

Kirton in Lindsey Town Council, as the Burial Authority, has a duty under Health and Safety legislation to control the dangers that exist in the cemetery. This includes work to actively remove hazards posed by unstable memorials.

It is Kirton in Lindsey Town Council's intention to follow the latest guidance from the Institute of Cemetery and Crematorium Management (ICCM) and the Ministry of Justice on memorial safety and to take appropriate action to any memorial deemed unsafe within the cemetery.



All memorials should be inspected on a minimum 5 yearly cycle. The inspection will be fully documented, identifying all dangerous or unstable memorials.

Following the inspection, those memorials requiring action are marked for the owner's attention. It is the owner's responsibility to undertake any works required. This could include contacting memorial masons for advice and guidance. The Council should be informed of any works taking place in the cemetery prior to them starting, and confirmation should be provided when works are completed. This enables the Council to update all reporting to confirm the required works have been carried out and to ensure that any works do not cause disturbance to memorial services planned within the cemetery.

The owner of the memorial is responsible for maintaining the memorial in good condition and will be properly informed by their memorial mason of their and other party's responsibilities. Where owners cannot be traced the Town Council has to make a decision on how to deal with a memorial.

Notice will be given for any intended action to any memorial. If all attempts to contact the grave owner fail than the Town Council has the right to remove or take such steps as to make safe the hazard. This will also be the case for memorials where the grave owner or their heirs-at-law have been contactable but were either unwilling or unable to ensure a repair by a registered stone mason.


Town Councillor Vacancy

Do you know about the free Pooper Snooper app which will allow you to easily flag up dog fouling incidents as and when you come across them, as well as register dog waste bins so that other dog walkers with the app can find their nearest bin.

The problem of dog waste on the pavements and open areas of Kirton in Lindsey is an ongoing concern, and Cllr Fox's work to promote responsibility and engage the North Lincolnshire Council (NLC) dog warden has helped with this a great deal. Kirton in Lindsey Town Council continue to engage with NLC on the locations of bins around the town to make sure they are in the right places, but this takes time. The free Pooper Snooper app provides an easy way to develop evidence-based feedback about areas of particular concern. This will help us identify the troublesome areas and we can look at further methods of targeting those, with the help of enforcement officers.

Don't forget, if you are able and willing to identify irresponsible owners who aren't picking up after their dog you can report them to North Lincolnshire Council to issue a fine.

The free Pooper Snooper app can be downloaded from the Apple or Google stores. Have a go and get logging!



Remember - by using the app to report dog fouling incidents, it creates a 'heat map' highlighting problems areas where new bins could be installed or enforcement officers could focus their time to help try to address this ongoing issue.


Play Area Survey - Results

One of the things we are back on with now that Covid restrictions have eased is development of the play area on the Green (and indeed elsewhere around Town as the opportunities arise). Here is a summary report of the main points to come out of the Play Park survey. A full report generated by Survey Monkey with all responses will appear on the Town Council website in due course. There are some usefully common themes that give us some direction for development of the play area and other parts of town where we may be able to offer some recreational facilities if things go our way. Thank you to everyone who filled the survey out, your time and thoughts are all appreciated.

Kirton in Lindsey Play Park Survey 2021, Summary of Results

This report gives a summary of the answers given in the 2021 Play Park Survey to assist with future improvements. There were 82 responses received. Thank you to all who completed the survey.

Q1) How often do you (or your children) use the play equipment on the Green?



Q2) Which pieces of equipment do you enjoy the most? Why do you enjoy them?

The most popular pieces of equipment at the park were:

- Slide & Slide Tower
- Supernova
- Sandpit / Boat
- Climbing Tower

The Spicas were popular with older children and the Stepping Logs were also popular with some of the younger children.

Q3) Which pieces of equipment don't you use or enjoy? Please let us know any reasons that you don't enjoy the park.

The Chimes and Bongos do not appear to be very popular, though the age range that they appeal to is limited.

There were some comments that the slide tower can feel unsafe due to the gaps between the bars.

There were comments that the items that people do not use are due to those individuals not being in the age range they are aimed at, rather than the equipment being disliked.

Some people commented that the amount of litter can be off-putting and they do not use items if they appear broken. The monthly play park inspections that are now undertaken by the Town Council should help to minimise time that any item of equipment is damaged and out of use.

Q4) Are there any new items or types of equipment that you would like to see?


The most common requests were for:

- · Zip wire
- Gym equipment
- Skate park
- · Bigger climbing apparatus or a climbing wall
- · Additional seating and picnic benches
- · More facilities for teenagers

There were several requests for the provision of football goals, basketball hoops and additional swings, including a basket type swing that can be used by multiple people.

There were also a couple of comments highlighting that a swing for use by disabled children would be welcome, as would the addition of a conventional roundabout and some form of trampoline equipment.

Q5) What sort of activities do you enjoy most?



Q6) What other activities do you use the Green for (for example picnics, informal football, meeting your friends).

The most popular responses were for meeting up, picnics and informal games of football.

Q7) What other playparks do you go to? Where are they, and what is it you like about them?

The most popular other parks were:

- Scawby
- Normanby Hall
- Northorpe / Blyton
- Central park, Scunthorpe,
- Brigg
- Broughton
- Uncle Henrys

The reasons that respondents liked these parks were that they offer a good variety of equipment and cater for all ages. The most popular feature was a zipwire, with gym equipment and the other potential additions identified in Question 4 also being frequently mentioned.


Litter is a frequent topic, with some of the other parks being commended for cleanliness and the lack of litter, with the understanding that some other parks have employed staff.

Q8) Is there anything else you would like to tell us or suggestions for the park?

Many of the comments included things identified in earlier questions, but with common themes.

- · More litter bins, regularly emptied
- More seating / picnic benches
- Pop up shop/café/hut
- Boundary path
- Pedestrian Crossing (which is something that the Town Council have tried to implement, but have been unable to get permission for)
- Additional equipment for the park as identified in earlier questions.
