Proposed One Way Traffic Regulation Order George Street & High Street, Kirton in Lindsey.

Further to previous correspondence and requests from Kirton in Lindsey Town Council and Regeneration Group, we are now planning to implement the one-way road system around the Market Place.

As you may recall, the proposals are:

George Street – One way in a northerly direction, from its junction with the Market Place up to its junction with King Edward Street

High Street – One way in a westerly direction, from its junction with Sylvester Street up to its junction with Market Place

To implement the scheme, we will be erecting necessary signs along with road markings as shown on the attached drawing and introducing an experimental traffic order, which will allow us to monitor the effectiveness of the measures over period of up to 18-months.

It is anticipated the works will be implemented on the Monday 24th January 2022, subject to the availability of resources.

I also enclose for your information a copy of the statutory notice and a statement of reasons. Objections to the proposal specifying the grounds on which they are made should be made within 6 months of the order coming into force or of the latest variation or modification of it.

Notice is hereby given that on 12th January 2022, North Lincolnshire Council made an Order under Section 9 of the Road Traffic Regulation Act 1984, the effect of which is to introduce a one-way traffic system in Kirton on the lengths of road set out in the Schedule and as per the detail shown on drawing YHN0056/006. The Order will come into effect on 24th January 2022 for an experimental period of 18 months. A copy of the Order, together with a statement of reasons and plan showing the lengths of road affected are on display at the Council Offices, Church Square House, DN15 6NL during normal office hours throughout the duration of the Order. It is the intention of the Council to consider, in due course, whether the provisions of the Order should be continued in force indefinitely. During the operation of the Order, the Highways Traffic Safety Manager Operations shall have the powers of modification/suspension set out in Section 10 of the Road Traffic Regulation Act 1984.

Within 6 months of the coming into force of this Order or of the latest variation or modification of it, any person may object to the making of an Order giving an indefinite continuation of it. Any such objection should be in writing specifying the grounds on which it is made and sent to the Traffic Safety Team, Billet Lane, Normanby Enterprise Park, Scunthorpe DN15 9YH. If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers of the Road Traffic Regulation Act 1984 or a requirement of that Act or any instrument made under it has not been complied with you may, within six weeks from the date on which the Order was made, make application for that purpose to the High Court.
