External auditor report 2017/18

On 28 September 2018 we issued a report detailing the results of our limited assurance review of Sections 1 and 2 of this authority's Annual Governance & Accountability Return for the year ended 31 March 2018. We explained that we were unable to certify completion of the review at that time. We are now in a position to certify completion of the review.

The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.


- Section 1, Assertion 5 has been incorrectly completed. As indicated by the internal auditor the smaller authority has failed to assess significant risks to a satisfactory level. A1AR, Box C, has been answered "no" to indicate such.
- The smaller authority has not restated the 2016/17 figure when assessing assets in Section 2, Box 9. Any assets identified that were excluded from the fixed asset register and Box 9 figure that were in existence in prior years should have been included. Please note that the Practitioners' Guide allows smaller authorities to use any reasonable valuation method, provided that the prior year figure is restated for consistency and comparability.

Other matters not affecting our opinion which we draw to the attention of the authority:

In the completion of the Annual Internal Audit Report, and their detailed report, the internal auditor has drawn attention to significant weaknesses in relation to the ROSPA safety inspection sheets not being regularly completed. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner.
