The Clerk updated the Committee to report that 65 responses were so far submitted to the Survey Monkey public consultation and that it was previously agreed for the survey to be available until the end of January.

GP 2101/05	<u>Grove Street Cemetery</u> a. The Committee received an update from Cllr Startin regarding developing guidance for grave diggers and memorial masons working within Grove Street Cemetery. Separate documents are now prepared for grave diggers and memorial masons and these make reference to the Regulations as required. Additional recommendations included specifying opening and closing times for the cemetery; specifying working days; noting a location for the placement of soil and decision on the removal of surplus soil. Work to continue on a register of approved memorial masons.
b.	<b>RESOLUTION:</b> That further recommendations are considered at the next Full Council meeting.Meeting.ACTION: Cllr StartinThe Committee discussed the damage caused to the central path within the cemetery and agreed actions required. Vehicles should not be entering the cemetery without the consent of the Clerk and memorial masons should therefore be using trolleys to transport headstones to plots. One side of the gate could be locked into place to prevent vehicular access. <b>RESOLUTION:</b> That quotations are sought for the repair of the path and for the widening of the path. <b>RESOLUTION:</b> That the locking of the gate is considered as part of the recommendations at the next Full Council meeting.
