MINUTES

PK2104/01 <u>Apologies</u>

a. The Committee discussed holding the meeting following the death of His Royal Highness Prince Philip, The Duke of Edinburgh on Friday 9th April and the current period of national mourning.

RESOLUTION: That the meeting is held but a one-minute silence is observed prior to any further discussion of the business of the Committee.

One minute silence was observed.

RESOLUTION: That condolences from the Town Council are sent to the Royal Family. ACTION: Town Clerk

Members of the public were asked if they wished to raise any issues. No matters were raised.

b. Apologies were received from Cllr Cooper and Olive Ovington.

PK2104/02 Declaration of Interests / Dispensations

a. No declarations of interest received.

b. A dispensation was granted to Cllr Frankish to enable her to take part in discussions relating to In Bloom without having to declare a personal interest as a member of the In Bloom Group. This decision was made as without the dispensation the number of persons prohibited from participating in any particular business would be so great a proportion of the body transacting the business as to impede the transaction of the business. This dispensation shall expire on the date of Town Council elections in May, 2023.

PK2104/03 <u>Minutes of the Previous Meeting</u>

The Committee considered the Minutes of the PK Committee Meeting held on 15th March 2021. **RESOLUTION:** *That the Minutes be signed as a true and accurate record.*b. The Committee received an update from the Clerk regarding tasks and actions, noting 7 outstanding actions from March and 11 ongoing from all previous meetings.

PK2104/04 Town Events

The Committee discussed actions required at this time regarding Town Events:

- <u>StreetSports Provision</u> The Clerk updated the Committee to report North Lincolnshire Council had advised the result of the grant funding application was likely to be given in mid-April.
- <u>Annual Town Meeting</u> The Clerk and Assistant Clerk updated the meeting to note that matters were in hand for the holding of the meeting on 26th April, with a good response from town organisations.

Cllr Gunn joined the meeting.

- <u>Christmas Festival</u> The committee discussed the legacy Christmas lighting.
 RESOLUTION: That the Committee makes recommendation to Full Council that the Council look to selling the lighting frames as the cost for refurbishment and display would be high.
- <u>Scarecrow Trail</u> Cllr Fox discussed proposals for the event this year and received full support and agreement from the Committee. The theme will be At The Movies; the timing point $4^{th} 11^{th}$ July, prize

donations will be sought from local businesses, a piece to be included in the next edition of Kirton First to promote the event.

RESOLUTION: That Cllr Fox approaches local businesses for prize donations and arranges a promotional piece to be included in Kirton First.

<u>Christmas planning</u> – The Clerk asked if any further update about proposals for Christmas lighting at the conker tree at Station Road / Church Street had been received from North Lincolnshire Council. Cllr Fox noted that none had and that she would chase this up.

RESOLUTION: That Cllr Fox liaises with NLC on matters around the conker tree.

PK2104/05 In Bloom

a. The Committee received an update from the In Bloom Group; orders were in place for planting in the areas managed by In Bloom volunteers, formal litter picking events to restart as soon as it is safe to do so, in line with Keep Britain Tidy guidance. The two new open-bottom planters had arrived and now needed to be put together and put into position. A meeting was due to be held next week to finalise planning and dates. It was further noted that the Kirton in Bloom competition would be running this year and in addition to the scarecrow event, In Bloom were encouraging 'Kirton Karts' flower displays by residents and local businesses.

b. Cllr Fox updated the Committee on the work to tackle dog fouling issues, noting improvements around the town since the start of the campaign and the only area of concern now appeared to be High Street. The posters entered into the competition will be displayed around the town shortly with the designers of them proving to be very pleased with their prizes donated by Cllr Fox and No.12 Chocolatier.

Cllr Garritt had made contact with North Lincolnshire Council to request the support of their Town Centres Manager with a regeneration and improvement scheme for the central area of Kirton in Lindsey.
