GP 2203/01 Apologies

Cllr Garritt noted with interest the aspirations expressed from one member of the NLC team for assisting with the creation of a skate park in a North Lincolnshire town and the hope to work with them to achieve this for Kirton in Lindsey. Cllr Cooper also noted the interesting advice received from the Team about inspection training opportunities which is to be further pursued by Cllr Fox. The Clerk noted the information required to confirm the Landfill Communities Grant Funding offer.

The Committee considered the works required following the Memorial Inspection work carried out in July 2021. The Committee agreed the first step was the provision of information to grave owners about the works required, about keeping the Town Council informed of works completed, and to demonstrate thanks for the works already completed. Information to also be provided about the options going forward, the costs for the Town Council to carry out works and the alternative of laying headstones down. Cllr Fox suggested research work is carried out to contact local families. Local newspapers, radio and TV options were considered to reach more people. Once information is published the response from the community can be collated to inform the suitable next course of action.

GP 2203/06 Tree planting

Cllr Kofoed provided further information received about the Northern Forest tree planning scheme. The types of trees and availability for them to be planted into gardens and borders was confirmed, as long as there is a clear intent to grow them as trees and not hedging, that landowners commit to entering them onto the NLC tree counter and that all the required trees can be delivered in one go to a central point for delivery to individual landowners. The need for local information to be provided about these opportunities was agreed. Tree planning at KLASSIC was also discussed, with the Assistant Clerk to arrange a meeting with the Internal Drainage Board.
